Sl. No.	The school is directed to ensure that :
1	The total number of sections of the school shall be restricted to 15. Any further increase of section shall require prior approval of the Board, subject to compliance with affiliation bye laws and availability of rooms of 500 sq. ft. dimension.
2	Ramp at the entrance was seen, however, ramp or lift to access upper floors was not shown in the videography. The school should make provision for CWSN students to access upper floors by a ramp or lift as prescribed by the RPWD Act 2016 and Circular No. 05 dated 06.03.2023 issued by the Board and submit the compliance through videography within 3 months on the SARAS portal.
3	Only one CWSN toilet has been seen in the videography. The school should make provision for CWSN toilets, separately for boys and girls on every floor as per RPWD Act and submit the compliance through videography within 3 months on the SARAS portal.
4	The math lab is seen as a temporary arrangement with models/equipment placed on small plastic tables. There is no workspace for students, seating and storage arrangement. Composite lab is not laid out properly. Equipment is placed on wooden tables. There are no work stations with proper utilities, safety measures like separate entry an exit, exhaust fans, seating and storage. The school shall upgrade the math lab and composite science lab as per SoPs issued by the Board within 3 months and submit compliance on SARAS with videography.
5	School shall appoint Counsellor and Wellness Teacher within 3 months and submit compliance on SARAS.
6	The sexual harassment committee of the school is headed by a male member. School is required to nominate a female member as head of the committee and submit the compliance.
7	The school library is undersized and congested and under stocked. no separate reading area for staff is seen. The school shall shift it to a bigger room of prescribed dimensions and upgrade its library as per SoP issued by the Board within 3 months and submit compliance on SARAS with videography.
8	The building certificate is not as per prescribed format and has no validity period. The school shall submit revised building certificate in the prescribed format with a validity period, within 3 months and submit compliance on SARAS.
9	The school shall ensure the training of its teachers with CoE Bhubaneswar within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 3 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month. Compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the
