**CIRCULAR**

*To, Heads of **Institution**  
of Affiliated Schools of CBSE.*

Sub: Reminder for uploading / updating prescribed mandatory Teachers' Detail on the school's website-reg.

Ref: (i)CBSE Circular Nos. CBSE/AFF./CIRCULAR/03/2021 dt. 05.03.2021, (ii) **CBSE/AFF/09/2021** 21.05.2021 and (iii) CBSE/AFF/Circular-MPD/2025/0008 dt.08.01.2025.

**Sir/Madam,**

The Board vide its circulars issued in the past as referred above has reiterated that the schools seeking affiliation with the Board shall develop and maintain its own functional website containing comprehensive information regarding the school including details i.e name of teachers along with their qualifications and upload updated self attested copies of the documents / information as a part of "Mandatory Public Disclosure" as per the format available at Appendix-IX to bring in the transparency which is also one of the essential pre-conditions for seeking affiliation with the Board.

The same is being mandated through various clauses of the Affiliation Bye-laws of the Board:

**Clause : 2.3.8 "WEBSITE"**


The school seeking affiliation shall develop and maintain its website providing all vital information regarding the school on the website.

**Clause .2.4.9 "WEBSITE"**

Every affiliated school will develop their own website containing comprehensive information such as Affiliation status, details of infrastructure, details of teachers including qualifications, number of students, address-postal and e-mail, telephone nos., copies of transfer certificates issued, etc. as may be directed by the Board from time to time. The website so created should also have information with regard to fees charged.

**Clause 14.5**

The school should prepare its annual report containing comprehensive information including name, address postal and e-mail, telephone numbers, affiliation status, period of affiliation, details of infrastructures, academic calendar, details of teachers including

qualifications, details of teachers' training, academic achievements, write up on all efforts made in the field of environment education, sports achievements, Innovations, overall results, PTA activities, important SMC decisions, number of students, etc. and post the same on school's website before 15th September of every year.

**Clause 5.4:**

The pupil teachers' ratio should not exceed 30:1 in the school. In addition to this there must be 1.5 teachers per section, excluding principal, physical education teacher and counsellor, to teach various subjects.

It has been observed that inspite of the repeated direction vide aforesaid circulars of the Board, the schools are not updating the information on regular intervals on the school's website or uploading incorrect details or invalid documents on the "Mandatory Public Disclosure". The information with respect to details of teachers & their qualification is invariably not found on the schools website or under Mandatory Public Disclosure.

The above information is critical for parents to be aware of the teaching facilities and academic infrastructure available in the school to ensure transparency in the functioning of the schools. As per clause 14.1, every school is bound to follow the Affiliation Bye Laws of the Board mutatis mutandis, thereby, making it mandatory on the part of schools to strictly comply with the directions issued by the Board with respect to information regarding qualification of teachers in its school's website as part of Mandatory Public Disclosure as per revised format of the Appendix IX latest for 15<sup>th</sup> February, 2026.

Non-compliance to aforesaid instruction shall be Viewed seriously as violation of clause 12.2.3, which may lead to imposition of penalty as laid down in Chapter 12 of the Affiliation Bye laws of the Board.

This issues with the approval of the Competent Authority of the Board.
